LOAN OPTIONS

Term Loans: Up to \$300,000

Terms: Affordable principal and interest payments with negotiable repayment period.

High Cost Debt Refinancing: Up to \$35,000

Terms: Loans made based on historical repayment of high cost debt. New loan structured to fully pay off the existing burdensome debt.

Line of Credit: Up to \$35,000

Terms: With built in flexibility, pre-approved amount of funds will be available through this loan when borrower needs to access it.

Merchant Loans: Up to \$35,000

Terms: Loans made based on historical revenue from credit cards. Payment of principal and interest secured by taking a small percentage of merchant's credit card charges.

Invoice/Purchase Order Financing: Up to \$100,000

Terms: Loans made based on contract awards or need to perform on a contract.

- Minimum equity participation of 10% of total project cost
- You have been unable to obtain financing through conventional sources
